

Introduction

1. Equiti Securities Currencies Brokers LLC is a company incorporated with limited liability in, and existing under the laws of, the United Arab Emirates, under registration number 1642447, whose registered address is at Office 202, Lamborghini Building, Um Al Sheif, Sheikh Zayed Road, Dubai, United Arab Emirates (**Equiti**).
